



Joint Research Bases: Research institutions from the partner country are to be linked with regard to staff, organization and funding with German research institutions and research in industry. Funding will be provided to measures to develop concepts for establishing joint research bases.

Which are the conditions for funding?

Applications for funding may be submitted by institutions of higher education and non-university research establishments in conjunction with partner institutions from CEE/SEE countries. Preference will be given to applications involving small and medium-sized enterprises.

The BMBF assumes that the CEE/SEE partners will contribute towards funding.

Funding for the preparation of joint research bases on the German side presupposes complementary funding by the foreign partner through a funding institution of the partner country.

The grant may amount to a maximum of 50,000 € for the preparation of particularly complex projects and joint research bases.

Applications are accepted and processed continually.

Die bilaterale Zusammenarbeit in Bildung und Forschung mit den Mittel-, Ost- und Südosteuropäischen Ländern steht im Zeichen der Osterweiterung der EU und der Schaffung eines Europäischen Bildungs- und Forschungsraums. Mit neuen Kooperationsformen und Fokussierung auf Schwerpunktthemen gegenseitigen Interesses soll die bilaterale Zusammenarbeit auf europäischer Ebene ausgebaut und damit ein bilateraler und zugleich europäischer Mehrwert geschaffen werden.

Mit der Regionalausschreibung werden Finanzmittel für Anbahnungsprojekte in der angewandten Forschung und Entwicklung und der Bildung bereitgestellt,

- um weiterführende Projektanträge in aktuellen Förderprogrammen des Bundesministeriums für Bildung und Forschung (BMBF) zu stellen;
- um die Vorbereitung von Projekten zu thematischen Prioritäten des kommenden 7. Forschungsrahmenprogramms der Europäischen Union (EU) sowie zu anderen forschungsrelevanten EU-Programmen zu unterstützen,
- um gemeinsame Forschungsbasisen aufzubauen.

Was wird gefördert?

BMBF Fachprogramme: Mit der Regionalausschreibung soll die Vorbereitung von Projekten der angewandten Forschung und Entwicklung und der Bildung zu den aktuellen Förderprogrammen des BMBF gefördert werden, insbesondere

- Neue Technologien
- Lebenswissenschaften
- Nachhaltigkeit

EU Forschungsprogramme: Ebenso soll die Vorbereitung von Projekten in der angewandten Forschung zu ausgewählten thematischen Prioritäten des kommenden 7. Forschungsrahmenprogramms der Europäischen Union sowie zu anderen forschungsrelevanten EU-Programmen gefördert werden.

In **Gemeinsamen Forschungsbasisen** sollen Forschungseinrichtungen aus dem Partnerland mit deutschen Forschungseinrichtungen und der forschenden Industrie personell, organisatorisch und finanziell miteinander verflochten werden. Gefördert werden Maßnahmen zur Ausarbeitung von Konzepten zum Aufbau gemeinsamer Forschungsbasisen.

Was sind die Voraussetzungen für eine Förderung?

Das BMBF geht davon aus, dass der MOE/SOE-Partner zur Finanzierung beiträgt.

Eine Förderung der Vorbereitung gemeinsamer Forschungsbasisen von deutscher Seite setzt eine komplementäre Förderung des ausländischen Partners durch eine Förderinstitution des Partnerlandes voraus.

Antragsberechtigt sind Hochschulen, außeruniversitäre Forschungseinrichtungen im Verbund mit Partnereinrichtungen aus den MOEL/SOEL. Anträge mit Beteiligung von kleinen und mittleren Unternehmen werden bevorzugt. Der Zuschuss kann bei der Vorbereitung besonders komplexer Projekte sowie gemeinsamer Forschungsbasisen maximal bis zu 50.000 € betragen. Anträge werden laufend entgegengenommen und bearbeitet.

- to establish joint research bases founded on existing co-operations.

What is funded?

BMBF Specialist Programmes: The regional Call is intended to support the preparation of projects in applied research and development and in education under the current funding programmes of the BMBF. These include in particular:

- New Technologies
- Life Sciences
- Sustainability

EU Research Programmes: Support is also to be given to the preparation of projects in the field of applied research related to selected thematic priorities of the forthcoming 7th EU Research Framework Programme and to other EU programmes which are relevant to research.


