Dear Members and Friends of EREF Network,

Under the high patronage of the Committee of the Regions, the fourth Forum – addressing pertinent issues of implementing Lisbon Agenda in European regions – is taking place this year on 5 and 6 June, 2008 in Nova Gorica

The Forum will bring together senior representatives of regional authorities and entities from business, research, innovation and education domains, as well as knowledge stakeholders from South-Eastern and Eastern Europe. Members of several other European networks, such as Lisbon Regions Network, NIROC, IGLO, ERRIN, RIBN are also expected to actively participate in the Forum.

This year the Forum has two main goals. Firstly, it will contribute to raising awareness among knowledge stakeholders on the strategic importance of comprehensive and effective implementation of all aspects of Lisbon policies. Secondly, the adoption of a number of specific recommendations to be addressed to EU institutions, national and regional entities as well as all categories of knowledge stakeholders to formulate and efficiently implement knowledge society policies through learning from best practice cases from around Europe.

Several Lisbon coordinators in European regions are expected this year and they will exchange experiences in implementing Lisbon Agenda policies.

The special focus of EREF 2008 is the role of private public partnerships and private funding in the fields of RTD, innovation and education. The Forum is expected to encourage and motivate participants in enhancing their knowledge based competitiveness and contribute to accelerated realization of the concept of European Research Area.

Before the Forum in April and May, series of preparatory workshops in Graz, Trieste, Prague, Istanbul and Novi Sad will be organised by EREF partners. The proposals of conclusions and recommendations from these workshops will be presented to the Forum on the second day in presence of Commissioner for Regional Policy Prof. Danuta Hübner and President of Committee of Regions Mr. Luc Van den Brande.

The working languages of the Forum are English, Slovenian, Italian, Serbian and Croatian. In order to facilitate active and productive involvement in Forum deliberations, the participants will receive before the event the following two documents:

- 1. Analytical Compendium of EU decisions and recommendations in the field of the development of knowledge society, with particular emphasis on financing research, innovation and education;
- 2. Directory of schemes and support programmes in the EU, Member states and European regions for research and innovation projects.

The Forum will also provide participation with opportunities to establish fruitful contacts and to hold exploratory discussions about possible joint projects. 

## **Draft-Programme EREF-2008**

The EREF Forum in Nova Gorica (European Regional Economic Forum) is a platform of European regions on knowledge economy and society, and has also acted as a bridge between EU Member states and countries of South-Eastern Europe supporting them in their efforts of gradual integration with the Union through discussing policies and measures aiming at implementing the Lisbon Strategy and through the presentation of good practices from European regions.

The fourth Forum in Nova Gorica will bring together about 250 representatives of the economic, research, innovation and education spheres, as well as local and regional actors from EU regions and countries, and regions from South-Eastern and Eastern Europe.

On behalf of the EREF Network the Forum is organised by the Municipality of Nova Gorica, the Government Office for Local Self-government and Regional Policy, together with the Slovenian and Business Research Association in Brussels, under the patronage of the Committee of the Regions and sponsored by HIT Nova Gorica. Members of several European networks will actively participate in the Forum, such as: Lisbon Regions Network, NIROC, IGLO, ERRIN, RIBN, and others.

The EREF Network consists of the following 16 regions: Stockholm, Lapland-Oulu, Flanders, Wallonia, Scotland, Baden Württenberg, Styria, Friuli Venezia Giulia, Lombardia, Emilia Romagna, Valencia, Cataluña, West Pannon, Slovenia, Croatia, Turkey.

The profile of EREF-2008 participants will include the following categories:

- Regional Lisbon Agenda Coordinators, as well as Cohesion policy Coordinators, policy makers and senior executives from national institutions in the fields of RTD, innovation and education from the public and private sectors;
- ii. Senior executives from companies, research institutes, regional development agencies, entities supporting innovation activities, universities and other institutions of higher learning, business associations, technology parks, and other national and regional knowledge stakeholders.
- iii. Senior representatives of financial organisations and groups: banks, investment companies, funds management companies, business angels, etc.
- iv. Representatives of EU institutions, European associations, thinktanks, and other non-governmental organisations supporting the implementation of Lisbon Agenda;
- v. Media representatives specialized in research, innovation and education.

Thanks to the cooperation of authorities and experts from European regions – members of EREF Network, the EU institutions and European associations, the participants of the Forum will learn about the best practices in gaining competitiveness in the knowledge-based society through cooperation among different actors from the public and private sectors, thanks to the support of European, national and regional institutions.

Proposals of conclusions and recommendations for targeted and necessary actions to successfully implement the Lisbon strategy will be presented in Nova Gorica, produced through 5 preparatory workshops which will be organised by EREF partners during their own workshops, like in Graz, Prague, Trieste, Novi Sad, Istanbul and Portorož.

The SBRA team, as EREF Secretariat has been scanning since Automn 2007 hundreds of documents, studies, and conference papers containing conclusions and recommendations on relevant topics adopted recently by the Commission and other EU bodies, as well as by various European associations – including all relevant documents adopted during the Slovenian EU Presidency - and thereby assist the workshop organizers to offer for discussion a good collection of ideas to be structured and prioritized within a set of interrelated policies and measures supporting knowledge economy in European regions, and implementation of the Lisbon Agenda.

The Forum will adopt a set of recommendations which will be addressed to the EU institutions, national and regional entities, but equally to companies and institutions active in research, innovation and education. These recommendations will be distributed very broadly around Europe, and should contribute to the debate in Europe, and should encourage more decisive activities in favour of knowledge society and enhancement of international, knowledge-based competitiveness. An effort will be made to increase the awareness of stakeholders about their own

responsibilities and indeed interest to permanently innovate and strengthen their human capital base.

The Forum will also aim at accelerating the realization of the concept of the European Research Area (ERA), to which all European countries and regions from the Baltic sea to the Balkans are to be committed. Discussions will focus on the following issues through evaluation of selected good practice:

- upgrading the levels and efficiency of public RTD funding through better communication and closer collaboration between public and private sector;
- Ways of opening regional and national RTD programmes and innovation support schemes to other ERA stakeholders;
- Effective use of Structural and Cohesion funding for building RTD infrastructure for knowledge economy;
- Fiscal incentives for corporate RTD investment;
- Fuller use of philanthropic funding for supporting knowledge economy;
- Knowledge sharing systems as support to innovation;
- Making the researchers' profession more attractive;
- Bologna-type reforms and closer business-university collaboration;
- Mobility of top experts among academic life, business, and administration?
- Enhancing economic, social and political values of a European knowledge society model;
- Implications of knowledge society model for education and training.

In order to ensure an active and productive participation of potential participants to the Forum, they will receive a few weeks before the event an "Analytical Compendium of EU decisions and recommendations in the field of the development of knowledge economy, with particular emphasis on financing research, innovation and education".

Besides organized mutual learning – like every year - the Nova Gorica Forum will be a good opportunity for the participants to establish fruitful contacts and to hold exploratory discussions about possible joint projects. For participants from South-Eastern European countries the Forum will provide an opportunity to discuss with representatives of the EU institutions and to complete their EU documentation (a number of useful brochures, reports and manuals published by the different EC offices will be available at the Forum).

The participants are also encouraged to deliver beforehand, or bring along some promotional material about their organisation/region or project, which will be available for participants. Upon request, the organizers can organize for participants bilateral meetings, preferably with their interests indicated before the Forum.

Again this year the participation at the Forum will be free of charge. This is the draft-programme which will be updated at the Forum's Portal: www.eref.si.

The Forum on PPP and Private Funding of RTD, Innovation and Education activities at the regional level covers activities representing the core of the European research Area, the focus of the Forum will be placed on which funding instruments and their

combinations should be used and further developed in order to best accelerate the process of building knowledge society.

The Forum discussions represent also a response to the invitation of DG RTD from the last chapter of the ERA Green Paper of 4 April 2007 for public debate among stakeholders and a consultation with them on how to best implement the proposals and initiatives.

The findings of the EU project on support to RTD policy and funding (BIS-RTD) will be disseminated among the Forum participants, and some participants will be invited to take part in the Joint Validation Workshop to be held on the morning of Saturday 7 June in Nova Gorica.


