2. Eligibility Criteria for Young Researcher Candidates:

- At least a university degree in a relevant subject, obtained in a study programme adopted in the Republic of Slovenia before 11 June 2004, with at least an average grade 8.00 in all examinations and practical courses (excluding the diploma) and fulfilling the terms and conditions for admission to a third-cycle postgraduate course, or
- A degree obtained in a second-cycle study programme in a relevant subject, adopted in the Republic
 of Slovenia after 11 June 2004, with at least an average grade 8.00 in all examinations and practical
 courses in the first-cycle and second-cycle study programmes (considering also the grade of the
 Bachelor's and Master's theses); or
- A Master's degree obtained in a Master's study programme adopted in the Republic of Slovenia before 11 June 2004, or
- A level of education obtained at a university abroad, yet comparable to that required in accordance with the first, second and third indents above,
- Age up to and including 28 years (by considering the year of birth); the age limit is raised above 28 years if the young researcher has already completed one or two years of third-cycle postgraduate studies without financial support. In this case one year is added for each year completed.

If at the time of the conclusion of the contract, the young researcher candidate is enrolled in the second or third year of a third-cycle study programme, the average grade of the undergraduate studies under a study programme adopted in the Republic of Slovenia before 11 June 2004, or the average grade of all the examinations and practical courses of the first-level study programme and the second-level study programme shall be irrelevant. If the candidate has obtained a Master's degree under a Master's study programme, adopted in the Republic of Slovenia before 11 June 2004, the average grade in the Bachelor's degree programme shall be irrelevant. If the young researcher candidate has taken parental leave for at least six months, taking into account one year for each child, the age limit shall be raised above 28 years. The same shall apply to a prolonged documented sick leave of at least six months.

The Agency will not fund young researcher candidates who, at the time of signing the contract, are enrolled in an additional year of a third-cycle study programme or have already benefited from such status, candidates who have already been funded through the Agency in a young researcher programme and candidates who have already been awarded a Doctor's degree.

3. Criteria for Evaluating Young Researcher Candidates:

- Average grade in all examinations and practical courses (excluding the diploma) in a university study
 programme adopted in the Republic of Slovenia before 11 June 2004, and/or in a first-cycle study
 programme and a second-cycle study programme; at least 80% of all examinations shall be passed and
 practical courses completed;
- Already obtained Master's degree under the Master's study programme adopted in the Republic of Slovenia before 11 June 2004;
- Enrolment in a third-cycle study programme;
- Awards or distinctions received;
- Published articles;
- Participation in research;
- Evaluation of the interview with the candidate.

4. Application:

The application under the Call for Tenders **must** include:

1. Application form MR/2021 – fully completed and signed





2. Proof of educational qualifications

- Proof of a diploma awarded upon completion of a study programme adopted in the Republic of Slovenia before 11 June 2004, or proof of completion of a first-cycle study programme and a secondcycle study programme, or a certificate of defence of a Master's thesis obtained in a Master's degree programme adopted in the Republic of Slovenia before 11 June 2004, and
- Annex to the diploma or two annexes to the two diplomas, if the young researcher candidate is
 enrolled in the first year of a third-cycle study programme, or a certificate of passed examinations
 and completed practical courses, if the young researcher candidate has not yet been awarded a
 diploma. If the candidate is already enrolled in a third-cycle postgraduate programme, he/she shall
 attach a certificate of enrolment and a proof of completion of the requirements for the postgraduate
 programme;
- Proof of the average grade in the undergraduate studies (i.e. a diploma supplement or an officially certified list of all examinations passed and practical courses taken, showing the average grade calculated to 2 decimal places). At least 80% of all examinations shall be passed and practical courses completed.
- **3. Proof of nationality** (photocopy of identity card or passport).

4. Declaration

- DECLARATION No. 1 Candidate's declaration to take his/her Bachelor's or Master's degree by 14
 September 2021 inclusive and to submit a certificate of diploma or of defence of his/her Master's
 thesis by the same day (if the candidate has already been enrolled in a postgraduate course, he/she
 shall attach the certificate of enrolment and a proof of the fulfilled obligations in the postgraduate
 course).
- **DECLARATION No. 2** Candidate's declaration about the protection of personal data.
- DECLARATION No. 3 Candidate's declaration that he/she has not yet been funded under the Young Researcher Programme (if the candidate has already been enrolled in a postgraduate course, he/she shall attach the certificate of enrolment and a proof of the fulfilled obligations in the postgraduate course).

The following attachments **may** also be attached to the application:

- Proof of prizes and awards received, list of published scientific articles and proof of participation in research;
- Proof of any maternity or parental leave or prolonged sick leave, if any.

5. Young Researcher Candidates – Foreign Nationals and/or Foreign Graduates

Foreign nationals and/or young researcher candidates applying under the present Call for Tenders shall have all the necessary documentation for employment in the Republic of Slovenia ready by 14 September 2021 (DECLARATION No. 1).

If a young researcher candidate has not completed his/her first-cycle and/or second-cycle study programme and/or his/her Master's study in the Republic of Slovenia, he/she shall also send to the Institute the following items before signing the contract:

- Decision by the higher education institution on the recognition of foreign studies for the purpose of studies in the Republic of Slovenia; and
- Conversion of the average grade of all examinations and practical courses of the first-cycle study
 programme or second-cycle study programme according to the assessment system applied at higher
 education institutions in the Republic of Slovenia, such as prepared by the Institute providing the
 course, taking into account the assessment system of the studies completed abroad.





6. Term of Employment:

Institute will conclude an employment contract for the duration of the doctoral studies, precisely for the duration of the funding period as laid down in Article 116 of the Rules on Procedures for (Co-)Funding, Evaluation and Monitoring of Research Activities.

7. Applications to the Call for Tenders

Young researcher candidates should submit their applications including the required attachments by e-mail to: mr2021@ijs.si.

The tender documentation is available on the Institute's website during the call period.

The deadline for the submission of complete applications to the call for tenders is Friday 2 July 2021.

Only <u>complete applications</u> received at the Institute's address by the deadline will be considered for the selection process.

The selection of the young researcher candidates will be carried out by the Institute in agreement with the selected mentors. Candidates will be informed of their selection in writing.

8. Additional information and warnings

Selected young researcher candidates must apply separately to the call for enrolment to postgraduate study programmes at the selected faculty of postgraduate studies in the academic year 2021/2022. Young researcher candidates who do not enrol in a postgraduate programme by the enrolment deadlines will not be able to conclude a Young Researcher Training Contract with ARRS.




