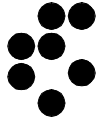

AGREEMENT ON CONFIDENTIALITY AND TRANSFER OF INTELLECTUAL PROPERTY RIGHTS

Entered into by and between:

Article 1

The Student undertakes not to use the information specified in Article 2 of this Agreement, obtained in the period from to the end of cooperation with organizational unit /JSI during the said cooperation in the form of student work and support and assistance at drafting of documents, projects and other tasks, for his own personal benefit and will not disclose such information to unauthorized persons, but will merely use the acquired information for the implementation of tasks imposed by the organizational unit /JSI.

The Student expressly agrees not to use, disclose, copy or otherwise reproduce or publish confidential information for his/her own or any third party's benefit without the Institute's written consent.

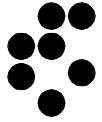
At the request of the Institute, the Student shall immediately return all notes, documents in written or electronic form and/or any other media containing confidential information.

Article 2

The information under this Arrangement includes:

- Any information, data and content belonging to JSI or JSI's business partners involved in the projects, provided to the Student verbally, in writing or otherwise,

- Any information of such nature that its disclosure would evidently cause JSI substantial harm if disclosed to an unauthorized person,
- Any information and/or content that has or may have any market value or any other value whatsoever,
- Any information that constitutes potential or actual economic value.

This information excludes:

- Information that is made public through no fault of the Student,
- Confidential content for the disclosure of which the Student has acquired Institute's prior written consent,
- Information that is public by law.

Article 3

The Student shall be held materially responsible for any violation of the provisions of this agreement's provisions on confidentiality and shall reimburse the Institute for all material damage thereby incurred by the Institute.

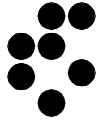
Article 4

By signing this Agreement, the Student transfers to the Institute all economic rights relating to the works protected by copyright and created by the Student as author or co-author during his/her cooperation with the Institute, including the rights of reproduction, transformation, distribution and making available to the public. The transfer of rights is exclusive and unlimited geographically and in time, while the Student allows the Institute further transfer of all rights to third parties, for commercial or non-commercial purposes.

By signing this Agreement, the Student transfers to the Institute all rights in the inventions that he/she creates or participates at their creation during his/her cooperation with the Institute, as well as any other creations that may be protected with industrial property rights.

The transfer of rights in accordance with the first and the second paragraph of this Article shall not interfere with the Student's moral rights and/or the Student's right to be listed as the inventor of the invention.
